**COOPERATION CONTRACT**

**I. Object of Contract**

Object of the contract is provision of one-off reproduction right to the maps, plans and atlases from the Map Collection of the Faculty of Science, Charles University (hereinafter referred to as “MC”) by the provider to the assignee.

**II. Subject Matter of the Contract**

Subject matter of the contract is an obligation of the provider to provide the assignee with one-off reproduction right to maps listed in Annex No. 1 (hereinafter referred to as “the work”) and obligation of the assignee to settle the agreed remuneration for the provision of this reproduction right. The reproduction is taken by the assignee for the purpose .....

**III. Payment Provisions**

Provider shall provide the assignee with the work from MC stated in the article II of this contract in order to meet purposes of the assignee as stated above. The provision of the work for reproduction entitles the provider to charge the remuneration according to the price list, which is Annex No. 2 of the Decree of the Dean of Charles University in Prague, Faculty of Science No. 18/2011 (hereinafter referred to as “remuneration”). The remuneration is payable prior to the provision of the work for reproduction. For the provision of the work for reproduction, the provider sets the remuneration in the amount of EUR .....

The assignee is obliged to pay the remuneration on the basis of an invoice issued by the provider. The remuneration shall be paid by non-cash transfer to the account of the provider specified in the contract header. The invoice is payable within 14 days from the receipt of the invoice.

#### IV. The Mutual Rights and Obligations

The assignee is entitled to use the provided reproduction of the work only for his needs and for the agreed purpose stated in the article II of this contract. The assignee is not entitled without the prior consent of the provider to enable other natural or legal person either at home or abroad to use anyway the provided reproduction of the work.

Provider represents that it is in possession of the copyright and is entitled to assign and transfer such right under the terms and conditions of this agreement. Provider warrants that no third party has any exclusive right or claim for remuneration with respect to the work that would restrict or prevent Assignee's acquisition and use of right under this agreement (legal warranties).

The assignee is obliged to provide under the reproduction of the work (in the film document end titles in the list of cooperating institutions) © Charles University, Faculty of Science, Map Collection, www.mapovasbirka.cz.

The assignee is obliged to pay the provider one-time contractual fine in the amount of EUR 100 for each individual case of breach and at the same time to pay incurred damage in case of breach of the obligations stipulated in the preceding paragraphs of this article.

The assignee is obliged to deliver the final copy of the work to the Map Collection in the form it was published in.

#### V. Other Provisions

All the amendments of this contract may be made only in the form of written numbered annex confirmed by both contracting parties.

The contract is concluded for a term of 5 years.

The contract is valid and effective from the day of its signing by both contracting parties. The provider is entitled to immediately withdraw from the contract if the assignee fails to pay the agreed remuneration by the date stated in the article III of this contract.

The contract is executed in two counterparts, which are equally valid. The assignee receives one copy and the provider receives one copy.

The contracting parties declare that this contract is a free act and deed and it has not been concluded under duress or under obviously disadvantageous terms. In witness whereof the parties set their hands.
